

DIGEST: Stolthaven is continuing the phases of their new automation project and is requesting an ITEP for 80% reduction of ad valorem taxes. The Parish Council has the ability to grant or deny this request. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
- i. A Resolution designating the Fiscal Agent for the Parish of Plaquemines for the period commencing June 1, 2023 and ending May 31, 2025. COUNCIL MEMBER LAFRANCE
DIGEST: A resolution to designate Regions Bank as the Fiscal Agent for Plaquemines Parish Government. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
- j. An Ordinance to amend the 2023 Operating Revenue and Expenditure Budgets; to accept a donation from Inframark LLC for “Plaquemines Parish Day” at the Louisiana Legislature; and otherwise to provide with respect thereto. COUNCIL MEMBER LAFRANCE
DIGEST: Accept a \$1,000 donation from Inframark LLC to be utilized for “Plaquemines Parish Day” at the Louisiana Legislature. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
- k. An Ordinance to amend the 2023 Manpower Structure; and otherwise to provide with respect thereto. COUNCIL MEMBER LAFRANCE
DIGEST: An ordinance to create and fund one part-time Tractor Driver II position in the road maintenance public right of way department. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
- l. An Ordinance directing the Plaquemines Parish Government Finance Department on the appropriation of the annual rollover funds; and otherwise to provide with respect thereto. COUNCIL MEMBER SCHULZ
DIGEST: An ordinance directing the Plaquemines Parish Government Finance Department to designate twenty percent of the annual rollover funds once the annual audit is completed to the Parish Surplus Designation. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
- m. A Resolution authorizing the Parish President to enter into a Cooperative Endeavor agreement between the Louisiana Young Artists and Young Authors (LAYAYA), and further authorizing the President to sign, on behalf of Plaquemines Parish Government, any and all documents necessary and proper to perfect or enforce this agreement; and otherwise to provide with respect. COUNCIL MEMBER SCHULZ
Digest: This is an CEA between Plaquemines Parish Government and LAYAYA for storage space on the government complex. PPG will not fund any activities of LAYAYA. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*

DIGEST: An ordinance to unfund one vacant full-time EMT-Paramedic position and fund two part-time EMT-Paramedic positions in the ambulance department. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
