As per the recreation committee meeting on May 28, 2020, the following items were discussed. The PPG recreation committee has discussed and unanimously, except District One representative who was not present, decided effective January 1, 2021 to increase all PPG sponsored recreational sports registrations fees from \$25 to \$50. The only exception will be football, the registration fees for football will increase from \$25 to \$100 with \$25 returned if the PPG football equipment is returned in a timely manner set by the recreation department. Uniforms will be included with the registration fee. All adult sports registration fees will increase to \$200. Rental fees for PPG parks will increase to \$200.
