20   WHEREAS, Ordinance 15-133 adopted October 8, 2015 placed a hiring freeze on all new positions  
21   and all vacant positions of Plaquemines Parish Government, including Classified and Unclassified  
22   positions, with the exception of emergencies which must be addressed by Ordinance; and

23   WHEREAS, the Parish Council desires to authorize an emergency exception to the hiring freeze;
