## COVID-19 (Coronavirus) Update

The Plaquemines Parish Government is monitoring COVID-19 (Coronavirus). Residents are asked to monitor local media for more information as it becomes available. For COVID-19 Testing, residents may go to Plaquemines Medical Center. The public is advised to take regular CDC (Centers for Disease Control and Prevention) precautions & protective measures at this time

- Stay safe when doing essential activities:
  - **Shopping for Supplies:** send only one family member, wash hands before and after shopping, don't touch your face, and avoid close contact with others.
  - **Food Delivery:** avoid close contact with others, use sanitizing wipes, wash your hands before and after deliveries, request deliveries be left outside your door, disinfect all packaging.
  - **Essential Work:** disinfect work area often, avoid close contact with others, and meet virtually.

- Clerk Office remains staffed and open but limited to no access by the public. We are serving them in the lobby of the building. Less than 5 walk-ins per day and we discontinued birth certificates and passports.

#### **Plaquemines Parish Fire/EMS (NSTR)**

- Working closely with Plaquemines Parish Government and Department of Homeland Security in following guidelines from Federal and State Agencies as recommended
- Having all personal disinfecting and sanitizing all stations and vehicle as well as safe hygiene practices.
- In the process of procuring additional cleaning supplies and personal protective equipment.

### **Riverbend Nursing & Rehab (NSTR)**

- Facility is closed to all visitors, vendors, providers, etc. (only staff and residents)
- All non-critical appointments for our residents have been rescheduled
- All staff are screened prior to entering the facility
- Daily in services are being provided on infection control, proper hand washing technique, proper technique for application and removal of PPE
- In addition to regular cleaning, common areas and flat services are being disinfected 3x per day using Super Sani-cloth germicidal disposable wipes
- All departments have stocked up all emergency supplies to prepare for a shelter-in-place event.
