## **COVID-19 (Coronavirus) Update**

The Plaquemines Parish Government is monitoring COVID-19 (Coronavirus). Residents are asked to monitor local media for more information as it becomes available. The public is advised to take regular CDC (Centers for Disease Control and Prevention) precautions & protective measures at this time.

- Plaquemines Medical Center will receive more COVID-19 Testing
- PMC has requested more test
- Social distancing is absolutely critical right now to slow the spread, protect our vulnerable community members, and prevent the healthcare system from becoming overwhelmed.

### **Plaquemines Parish Clerk of Court (NSTR)**

- Presidential Preference Primary Election in Plaquemines Parish has been moved from April 4<sup>th</sup> to June 20<sup>th</sup> and the General Election has also been moved from May 9<sup>th</sup> to July 25<sup>th</sup>
- Passport and birth/death certificate service is suspended until further notice

### **Plaquemines Parish Fire/EMS (NSTR)**

- Working closely with Plaquemines Parish Government and Department of Homeland Security in following guidelines from Federal and State Agencies as recommended
- Having all personal disinfecting and sanitizing all stations and vehicle as well as safe hygiene practices.
- In the process of procuring additional cleaning supplies and personal protective equipment.

### **Parish Health Department (NSTR)**

- Fielded questions from food retail community to discuss state mandated closures and limitations.
- Closed the Health Department to unscheduled walk-ins. Posted note on entrance to call the Health Department for further assistance.
- Continued with email correspondence from LDH regarding employment policy, 211, and FAQ's.

### **Plaquemines Port Harbor & Terminal District (NSTR)**

- PPHTD has put signage for proper hand washing and good hygiene.
- In addition, added hand sanitizer stations at the Port office and all vessels.
- The Port is conducting business as usual. All personnel are expected in to work on Monday unless need to work from home due to school closures.
- We are following the lead of Coast Guard regarding vessel monitoring and security.
- Due to the current situation, we are suspending use of PPHTD vessels to bring USCG Boarding teams to ships effective immediately. In addition, we will only make Contact with other Mariners and Vessels in the PPHTD'S DISTRICT on a case by case basis after all the proper agencies have been notified.

### **Louisiana SPCA Plaquemines Parish Campus (NSTR)**

- In response to the recommendations put forth by the Center for Disease Control regarding social distancing, beginning Wednesday, March 18, the Louisiana SPCA will require all visitors to schedule an appointment to limit the number of people inside each facility at one time.

### **Chevron Oronite – Oak Point Plant (NSTR)**

- Evaluating our workforce to provide alternative working schedules as needed.
- Regularly updating our workforce as we receive more information and encouraging everyone to focus on the health and safety of their families, minimizing their exposure, and practicing good hand hygiene.
- Oak Point is taking precautionary measures to reduce the risk of exposure, including screening workers and visitors at company facilities.

### **Alliance Refinery-Phillips 66 (NSTR)**

- No changes in the operational plans for refinery employees
- Increase cleaning and healthy practices throughout facility
- Sanitizing done numerous times a day
- Non-business critical staff to work remotely

### **Riverbend Nursing & Rehab (NSTR)**

- NO confirmed or suspected cases within our facility
- Facility is closed to all visitors, vendors, providers, etc. (only staff and residents)
- All non-critical appointments for our residents have been rescheduled
- All staff are screened prior to entering the facility
- Daily in services are being provided on infection control, proper hand washing technique, proper technique for application and removal of PPE
- In addition to regular cleaning, common areas and flat services are being disinfected 3x per day using Super Sani-cloth germicidal disposable wipes
- Emergency stock supply has been obtained for most items (exception is masks) and is secure in the event of a facility outbreak
- All departments have stocked up all emergency supplies to prepare for a shelter-in-place event.
