Eligible firms must have demonstrated experience in Professional Engineering, Architectural, and Construction Administration Services in Southeast Louisiana, and be licensed in the State of Louisiana.

## **SELECTION CRITERIA**

3. Nature, quantity, and value of work with parish and similar governmental entities, previously and presently being performed. **15%**
4. Capacity for timely completion of the work. **10%**
5. Past experience implementing HMGP, CDBG-DR, CDBG, FEMA and other outside funded projects. **10%**
6. Size and location of the firm. **5%**
